In a state where many insurance companies are domiciled, and is second only to New York in major corporate bankruptcies, he advises clients on procurement and coverage issues — especially D&O liability insurance — and on litigation arising from coverage disputes. He has also represented insurers in regulatory proceedings regarding the acquisition or change of control of Delaware companies, and has served as a hearing officer for the Department of Insurance in such proceedings.
