As of 2018, there were 44,000 women at the 200-highest grossing law firms in the United States. Of those, 6,200 were equity partners, and only 5,000 were non-equity partners. This represents only a 2-4 percent increase since 2013. As of 2017, minority lawyers made up 16 percent of law firms, but only 9 percent of law partners were people of color. Only 5 percent of general counsels at Fortune 500 firms are women of color. It's time for a change. This panel will discuss best practices in the recruitment, retention, inclusion and promotion of women of color.
